#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Leavenworth from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

• Utilities

• Third party cash receipting

• Cost allocation plan

#### RESULTS

In the areas we examined, the City's internal controls were adequate to safeguard public assets. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### ABOUT THE CITY

The City of Leavenworth was established in Chelan County in 1906. Known as the "Bavarian Village", the City and its 1,970 residents host more than two million tourists each year. The City provides services including water and sewer, garbage, law enforcement, fire protection, and parks and recreation.

An elected, seven-member Council and a separately elected Mayor govern the City. The Mayor appoints the City Administrator to oversee the City's daily operations as well as its 27 full-time and part-time employees. For fiscal years 2011 and 2012, the City had operating budgets of \$9,590,985 and \$11,166,364, respectively.
