AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Stanwood Transportation Benefit District from November 19, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Allowable use of funds
- Open Public Meetings Act
- Annual report submission compliance

INFORMATION ABOUT THE DISTRICT

The city of Stanwood Transportation Benefit District was created by Ordinance No. 1328, adopted on November 19, 2012. The District is a quasi-municipal corporation and independent taxing district created for the sole purpose of acquiring, constructing, improving, providing, and funding transportation improvements within the District. The District is an independent taxing district that can impose specific taxes and fees, either through the vote of the people or through District Board action. The legislative authority acts ex officio and in an independent capacity, which shall have the authority to exercise the statutory powers set forth in state law (RCW 36.73). The District had operating expenditures of \$41,687 in 2013, the first full year of operation for the District.
