### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to the Town management in a letter dated November 25, 2014 related to procurement of public works projects and allocation of shared costs. We appreciate the Town's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the Town of Fairfield from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Donations/fundraising
- Procurement (bidding/prevailing wage)
- Use of credit cards
- Allocation of shared costs

### **Financial**

Our opinion on the Town's financial statements is provided in a separate report, which includes the Town's financial statements.

### INFORMATION ABOUT THE TOWN

The Town of Fairfield serves approximately 612 residents in Spokane County. It provides an array of services including water, sewer, parks and recreation, street and general administrative services. The Town contracts with Spokane County for police, planning and economic development services. Spokane County Fire Protection District No. 2 provides fire protection services for the Town.

An elected, five-member Council with a separately elected Mayor governs the Town. The Council appoints management to oversee the Town's daily operations as well as its four employees. The Town operates on an annual budget of approximately \$1.5 million.
