AUDIT SUMMARY

Results in brief

In the areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the Town. We appreciate the Town's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Town of Waverly from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE TOWN

The Town of Waverly serves approximately 120 citizens in Spokane County. The Town employs one part-time employee and provides services including water, street maintenance, parks and general administrative services to its residents. An elected, five-member Council and a separately elected Mayor govern the Town. For fiscal years 2012 and 2013, the Town operated on annual revenues of approximately \$49,000 and \$105,000, respectively. The Town received more than \$50,000 in 2013 for a historical preservation project.
