## AUDIT SUMMARY

### Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated September 24, 2015, related to cost allocations. We appreciate the City's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the City of Burlington from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Disbursements/credit cards
- Cost allocation
- Advance travel
- Third party receipting
- Software security
- Safeguarding of assets
- Open Public Meetings Act

## INFORMATION ABOUT THE CITY

The City of Burlington is located in the north end of Skagit County and serves approximately 8,500 citizens. City services include police protection, Municipal Court, legal, building, engineering and planning, code enforcement, cemetery, animal control, fire protection, street construction and improvements, parks and recreation, public library, storm water and sewage disposal, senior services, finance and accounting and general administrative services.

An elected, seven-member Council and an independently elected Mayor govern the City. The Council appoints a City Administrator to oversee daily operations. The City has 93 full-time employees, 12 part-time employees and approximately 60 volunteer and seasonal employees. For fiscal year 2014, the City operated on an annual budget of \$25.4 million.
