### **AUDIT SUMMARY**

#### Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated October 21, 2015 related to pay and benefit approvals. We appreciate the City's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the City of Lynden from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll and benefits
- Cash receipting/third party receipting
- Policy adoption

- Planning Department
- Budget compliance
- Open Public Meetings Act

# INFORMATION ABOUT THE CITY

The City of Lynden serves approximately 12,920 citizens in Whatcom County.

An elected, seven-member Council and an independently elected Mayor govern the City. Council Members serve staggered, four-year terms. The City has approximately 77 full- and part-time employees, seven seasonal employees, and approximately 12 volunteers that provide an array of services including water, sewer, storm water, police, fire, Municipal Court and planning. For fiscal years 2013 and 2014, the City operated on annual budgets of \$72.3 million and \$57.4 million, respectively.
