AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Fircrest from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Third party receipting
- Conflict of interest
- Self insurance
- Cash receipting
- Petty cash and imprest funds
- Utilities

INFORMATION ABOUT THE CITY

The City of Fircrest, incorporated in 1925, serves approximately 6,555 citizens. The City provides public safety services, a Municipal Court, street improvements, parks and recreation, planning and building services and general administration. In addition, the City operates water, sewer and storm drainage utilities.

An elected, seven-member Council governs the City. Council Members select one of its members to serve as Mayor. The Council appoints a Manager to oversee the City's daily operations and its approximately 32 full-time employees. For fiscal years 2013 and 2014, the City operated on budgets of approximately \$23.6 million and \$24.4 million, respectively.
