#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Northwest Lincoln County Regional Public Development Authority from January 1, 2009 through August 19, 2011.

We evaluated internal controls and performed audit procedures on the activities of the Authority. We also determined whether the Authority complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Cash receipting
- Open public meetings/records laws
- Use of state grant and loan funds
- Payment/expenditures
- Disposition of surplus property
- Dissolution procedures

#### **RESULTS**

In the areas we examined, the Authority's internal controls were adequate to safeguard public assets. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### **ABOUT THE AUTHORITY**

The towns of Almira, Creston and Wilbur created the Northwest Lincoln County Regional Public Development Authority through an inter-local agreement in June 2001. The Authority's intended purpose was to help the communities create sustainable economic development opportunities. The agreement did not require the Authority to adopt a formal budget. Volunteers performed administrative tasks.

In 2002, the Authority built an industrial park with approximately \$945,000 of Community Economic Revitalization Board grants and loans. The original tenant was a livestock feed provider and in 2007 the building was repurposed into a biodiesel facility. The biodiesel tenant could not sustain its financial viability and the Authority has been unable to find another tenant for the property. In 2011, the property was sold and the remaining debt forgiven. The Board held its final meeting on August 19, 2011, and the Authority was dissolved.
