## ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Snohomish County from July 1, 2012 through June 30, 2013.

We evaluated internal controls and performed audit procedures on the activities of the County. We also determined whether the County complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Departmental review - Treasurer's Office
- Office of Housing and Community Development
- Equipment Rental and Revolving Fund - asset management
- Budget compliance
- Equipment leases
- Park fees
- On-call contracts
- Mechanic services
- General disbursements
- Collections
- Materials/supplies inventory

## ABOUT THE COUNTY

As of December 31, 2012, Snohomish County had a population of approximately 722,900 citizens. The County is governed by an elected, five-member County Council. Additional elected officials include County Executive, Prosecuting Attorney, Sheriff, Auditor, Clerk, Treasurer and Assessor. The County has 15 Superior Court judges and eight District Court judges who are also elected. All County officials are elected to serve four-year terms.

The County's 2,600 full-time employees provide an array of services including public safety, law enforcement, fire prevention, road construction and maintenance, parks and recreation, judicial administration, health and social services and general administration. The County also operates an airport and fairgrounds and is responsible for disposal of solid waste and controlling surface water run-off. For fiscal year 2012, the County operated on an annual general fund budget of $\$ 211,085,060$.
