ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Samaritan Healthcare from January 1, 2012 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

• Cash receipting – Parkview Pediatrics

- Charity care write-offs
- Travel reimbursement expenditures

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

Grant County Public Hospital District No. 1, doing business as Samaritan Healthcare, operates a licensed 50-bed acute care hospital in Moses Lake. The District also operates a rural health clinic and leases space to other health care organizations and professionals in Grant County.

An elected, five-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 500 employees. The District's operating expenses were approximately \$57 million during the 2012 fiscal year.

We audit the District annually. Only one finding has been reported in the previous nine audits. The finding was issued during our audit of fiscal year 2010 and was related to deposits held at banking institutions not approved by the state Public Deposit Protection Commission. That finding has been resolved.
