### Audit Summary

#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Prosser Memorial Hospital from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- General disbursements
- Credit cards and accounts
- Billing, adjustments and write-offs
- Charity care adjustments
- Surplus property
- Electronic health records incentive payments
- Procurement for public works

- Procurement for engineering services
- Stale checks, check integrity
- Unclaimed property
- Review of certified public accountant work papers for 2011 and 2012 financial audits

#### RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### FINANCIAL

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from the District. The firm reported a significant deficiency or material weakness in internal controls over financial reporting regarding the District's reconciliation of its operating cash account and incorrectly reporting beginning net position.

#### ABOUT THE DISTRICT

The Prosser Public Hospital District, doing business as Prosser Memorial Hospital, provides medical services in Benton County. The District owns and operates a cardiopulmonary center, a diagnostic imaging center, ambulance services, a birthing center, home health services, laboratory services, an acute care hospital, a hospital medicine program, surgical services, therapy services and a transitional and long-term care facility. There is also a rural clinic in Benton City.

An elected, seven-member Board of Commissioners governs the District. Members serve staggered, six-year terms. The Board appoints an Administrator to oversee the District's daily operations as well as its approximately 300 employees. For fiscal year 2011 and 2012, the District received revenue of approximately \$30.5 to \$30.8 million, respectively.

We audit the District annually; however, we performed a two-year accountability audit for the periods 2009-2010 and 2011-2012. The past five audits have reported one finding in 2006 regarding safeguarding capital and small and attractive assets. The issue has been resolved. District officials have been responsive to audit recommendations in the past. We appreciate the District's commitment to establishing public accountability.
