Audit Summary

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Dayton General Hospital and Columbia County Health System from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Procurement public works
- Procurement professional services
- Patient account write offs and adjustments
- Donations
- Open Public Meetings Act compliance

- Third party cash receipting and patient billing
- Payroll
- Credit card transactions
- Gifting of public funds
- Advertising

RESULTS

In most areas, the District complied with state laws and regulations and its own policies and procedures.

However, we noted certain matters that we communicated to District management. We appreciate the District's commitment to resolving those matters.

FINANCIAL

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from the District. The firm reported a significant deficiency or material weakness in internal controls over financial reporting regarding adjusting journal entries.

ABOUT THE DISTRICT

Columbia County Public Hospital District No. 1, doing business as Dayton General Hospital and Columbia County Health System, owns and operates several healthcare facilities in Dayton and Waitsburg. These facilities include Dayton General Hospital, a 25-bed critical access hospital, Booker Rest Home Annex, a 46-bed nursing home facility, Columbia Family Clinic and Waitsburg Clinic. The District provides health-care services including acute care, long-term nursing care, assisted living, emergency room, clinics and related services such as laboratory, radiology and therapy.

An elected, five-member Board of Commissioners governs the District. The Board appointed Chief Executive Officer is responsible for the District's operations as well as its approximately 125 employees. For fiscal years 2011 and 2012, the District operated on budgets of approximately \$10.9 million and \$10.6 million, respectively.

AUDIT HISTORY

We previously audited the District annually, but since 2009, we audit the District every two years. We reported a finding in the 2008 audit for an unallowable investment. This issue is still unresolved. We reported a finding on the District's financial condition in the 2007 and 2006 audits. This has been resolved. We have reported no findings since 2008.
