## City of Bonney Lake Pierce County March 31, 2014

### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Bonney Lake from January 1, 2012 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Financial condition
- Billings/receivables
- Cash receipting
- Open public meeting minutes

- Payments/expenditures
- Payroll
- Inter-fund transactions
- Procurement (bidding)

#### RESULTS

In the areas we examined, the City's internal controls were adequate to safeguard public assets. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### **ABOUT THE CITY**

The City of Bonney Lake, incorporated in 1949, serves approximately 17,500 citizens in Pierce County. The City provides a range of services, including police protection, public works, utilities, street maintenance, planning and permits, senior services, parks and recreation services as well as a Municipal Court. The City contracts with other public and private entities for garbage, wastewater treatment, jail, emergency dispatch and animal control services.

An elected, Mayor and seven-member City Council governs the City. The Council appoints management to oversee the City's daily operations as well as its 159 employees. For the 2011-2012 biennium, the City operated on a budget of approximately \$86 million.

#### **AUDIT HISTORY**

We audit the City annually. We reported one financial statement finding for the City in each of the 2007 and 2008 audits regarding inadequate controls to ensure accurate accounting and financial reporting. The finding was not resolved during our 2009 or 2010 audits. The finding was considered resolved for 2011 when the City presented cash basis financial statements. We again reported a financial statement finding for the 2012 audit regarding inadequate controls to ensure accurate accounting and financial reporting.
