Audit Summary

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Centralia School District No. 401 from September 1, 2011 through August 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open Public Meetings Act
- Apportionment
 - Enrollment
 - Transportation
 - Staff mix

- Financial condition
- Disbursements
- Procurement
- Credit cards

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

Description of the District

ABOUT THE DISTRICT

Centralia School District No. 401 provides public school services to approximately 3,400 students in kindergarten through 12th grade in Lewis County. It has one high school, one middle school and five elementary schools. The District operates the Centralia-Chehalis Transportation Cooperative and is a member of the Chehalis-Centralia Student Support Program Cooperative, which is operated by the Chehalis School District.

The District's five-member Board of Directors is the primary policy-making body, exercising budgetary and financial control for the District. Board Members are elected to staggered, four-year terms. The Board appoints a Superintendent who oversees the District's daily operations and its approximately 454 employees. For the 2012 and 2013 school years, the District operated on annual general fund budgets of \$35.9 million and \$37.2 million, respectively.

AUDIT HISTORY

We perform an accountability audit of the District every two years. The prior audit contained a finding regarding the procurement of a public work project. That finding has been resolved.

Status of Prior Audit Findings

Centralia School District No. 401 Lewis County May 6, 2014

The status of findings contained in the prior years' audit reports of Centralia School District No. 401 is provided below:

1. The Centralia School District awarded a contract to an unlicensed contractor without Board approval.

Report No. 1008043, dated July 2, 2012

Background

The District requested proposals to install fiber optic internet cable in its school buildings. The project included installation and lease of the cable for five years. The total contract was valued at approximately \$600,000 with \$100,000 for installation and the remainder for lease payments. Excavation work related to the installation makes this a public works project.

State law requires the District to perform responsible bidder checks prior to accepting a winning bid for a public works project. The District is also required to obtain Board approval prior to accepting a public works contract.

The District obtained three quotes from contractors and selected the lowest price, but did not perform the responsible bidder checks. In addition, staff signed the legally binding contract 35 days before it was presented to the Board for approval. We confirmed with the Department of Labor and Industries and the Utilities and Transportation Commission that the contract was awarded to a contractor who was not licensed to install cable.

Status

The condition reported during the 2010-2011 audit has been resolved. The District has improved internal controls related to the procurement of public works projects.
