## West Valley School District No. 363 Spokane County April 22, 2014

#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of West Valley School District No. 363 from September 1, 2011 through August 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Financial condition
- Summer school revenue
- Student transportation reporting
- Teacher education and experience (staff mix) reporting
- Student enrollment reporting

#### RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### ABOUT THE DISTRICT

West Valley School District No. 363 provides educational services to 3,775 students in kindergarten through 12th grade in Spokane County. The District has two high schools, a middle school and a non-traditional middle school, four elementary schools, one early education center, and two alternative education sites.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 500 employees. For the years under audit, the District operated on annual budgets of approximately \$41 million.

We perform a financial statement and federal single audit of the District each year and an accountability audit once every two years. The last six accountability audits have been free of findings. This history reflects the District's commitment to strong internal controls and compliance with applicable laws.
