## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated November 20, 2014, related to the timely preparation of the District's financial statements. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of North Spokane Irrigation District No. 8 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Payroll disbursements
- Cash receipting

## INFORMATION ABOUT THE DISTRICT

North Spokane Irrigation District No. 8 serves approximately 900 customers in Spokane County. The District is governed by an elected, five-member Board of Directors. The Board appoints a General Manager to oversee day-to-day operations. The District had annual operating revenues of approximately \$360,000, \$330,000 and \$690,000 for fiscal years 2011, 2012 and 2013, respectively.
