## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Eastmont Metropolitan Parks District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevaling wage)

## INFORMATION ABOUT THE DISTRICT

The Eastmont Metropolitan Park District was established on May 18, 2004, to provide parks and recreation services to the East Wenatchee area of Douglas County. The District maintains six parks and a swimming pool and organizes approximately 20 recreational programs.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Director to oversee the District's daily operations as well as its six full-time employees and a varying number of seasonal employees. For fiscal years 2012 and 2013, the District operated on annual budgets of approximately \$775,000.
