AUDIT SUMMARY

Results in brief

In the areas we audited, Commission operations complied with applicable requirements and provided adequate safeguarding of public resources. The Commission also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Washington State Beef Commission from July 1, 2011 through June 30, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Commission's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• QuickBooks adjustments

• Credit card disbursements

• General disbursements

INFORMATION ABOUT THE COMMISSION

The Washington State Beef Commission was established in 1969 by state law to support the approximately 9,000 beef producers and related industries in the state. It is funded from the state and federal Beef Checkoff Assessment Acts, which require a fee of \$1.50 every time a bovine is sold. The Commission is governed by a nine-member Board of Commissioners appointed by the Washington State Department of Agriculture.
