#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the Authority. We appreciate the Authority's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the King County Museum of Flight Authority from January 1, 2011 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

#### **INFORMATION ABOUT THE AUTHORITY**

Established by King County Ordinance on December 14, 1985, the Museum of Flight Authority was created to undertake, assist with or otherwise facilitate or provide for the development and operation of a first class air and space museum near Boeing Field in south King County.

A seven-member Board of Directors oversees the operations of the Authority. The King County Executive appoints the Board consisting of three members at large, three members nominated by the Museum of Flight Foundation and one member nominated by the Board of Directors.
