AUDIT SUMMARY

Results in brief

In the areas we audited, Board operations complied with applicable requirements and provided adequate safeguarding of public resources. The Board also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Liquor Control Board from July 1, 2012 through June 30, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Board's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Cash receipting
- Safeguarding/Disposal of assets (I-1183)
- Bio Track Traceability System (I-502)
- Payroll (I-1183)
- Enforcement
- Licensing

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE BOARD

The Liquor Control Board was established by the Steele Act to carry out a balanced mission of controlled distribution, regulation and enforcement of alcohol. The Board states its mission is to promote public safety and trust through fair administration and enforcement of liquor, tobacco and marijuana laws. The Board also strives to:

- 1. Ensure the highest level of public safety by continually improving and enforcing laws, regulations and policies that reflect today's dynamic environment.
- 2. Educate and engage licensees, the public and other stakeholders in addressing issues related to our mission.
- 3. Maintain and value a highly-motivated, competent and diverse workforce.
- 4. Build a culture that inspires and fosters excellence.

The Board is composed of three members, appointed to staggered, six-year terms by the Governor and confirmed by the Senate. An Agency Director, who reports to the Board, oversees and manages the day-to-day operations. The Board employs approximately 270 people throughout the state. The annual operating budget is approximately \$28.7 million for fiscal year 2014. Major sources of revenue include spirit, beer and marijuana taxes. The Board processes approximately 4,400 liquor applications a year and licenses over 21,000 alcohol-related businesses and 700 marijuana businesses.
