AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Snohomish Health District from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- General disbursements

- Small and attractive assets
- Pharmaceutical assets

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report issued in September 2015.

INFORMATION ABOUT THE DISTRICT

The Snohomish Health District was incorporated in 1959 and serves approximately 750,000 citizens in Snohomish County. The District provides the County with health services and education, examines the safety of restaurant and vendor-prepared foods and enforces water and sewer quality requirements.

The District's operations are governed by a Board of Health comprised of 15 representatives from member entities in Snohomish County. The Board appoints management to oversee the District's daily operations as well as its approximately 145 employees. For fiscal year 2014, the District operated on a general fund budget of approximately \$17 million.
