AUDIT SUMMARY

Results in brief

In the areas we audited, Agency operations complied with applicable requirements and provided adequate safeguarding of public resources. The Agency also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Clark Regional Emergency Services Agency from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Allocation of user costs
- Procurement

- Payroll
- Open public meeting minutes

INFORMATION ABOUT THE AGENCY

Clark Regional Emergency Services Agency was founded in 1976 under an interlocal agreement between seven cities within Clark County including Battle Ground, Camas, La Center, Ridgefield, Vancouver, Washougal and Yacolt, as well as unincorporated Clark County. The Agency receives and dispatches all 9-1-1 calls for Clark County, serving over 435,000 citizens. In addition, the Agency provides 9-1-1 communication for eight police departments, the Clark County Sheriff's Office, the City of Vancouver Fire Department and all fire districts and ambulance providers in Clark County.

The Agency is governed by an Administrative Board of Directors comprised of nine Board Members serving indefinite terms. The Board appoints management to oversee the Agency's daily operations as well as its 80 employees.
