AUDIT SUMMARY

Results in brief

In the areas we audited, Transit operations complied with applicable requirements and provided adequate safeguarding of public resources. The Transit also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Asotin County Public Transportation Benefit Area from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Transit's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Third party cash receipting
- Cash receipting
- Schedule of Expenditures of Federal Awards reporting

INFORMATION ABOUT THE TRANSIT

Asotin County established the Asotin County Public Transportation Benefit Area on May 27, 2003, to provide public transportation to the citizens of Asotin County. The Transit is located in Clarkston and offers fixed route, dial-a-ride and van pool public transportation to over 3,000 riders.

The Transit is governed by a three-member Board of Directors. Transit revenues come mainly from state and federal grants, sales and use tax and ridership fees. The Transit's expenditures were \$821,596, \$814,709 and \$891,421 for 2012, 2013 and 2014, respectively. The Transit's revenues were \$744,207, \$1,279,349 and \$1,242,592 for 2012, 2013 and 2014, respectively.
