AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Yakima County Fire Protection District No. 4 from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial reporting
- General disbursements

- Credit cards
- Fuel purchases

INFORMATION ABOUT THE DISTRICT

Yakima County Fire Protection District No. 4, commonly known as the East Valley Fire District, provides fire protection, prevention and emergency medical services to its service area. The District operates four fire stations in the region east of the city of Yakima, including the city of Moxee, east of Moxee on Highway 24, the Terrace Heights area and a regional training facility in the center of the District.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Chief to oversee the District's daily operations as well as its 12 full-time employees and 25 volunteer and paid on-call firefighters. The District is funded primarily through property taxes and a contract for fire protection services. The District operated on annual budgets of approximately \$1.5 million in 2012, \$1.6 million for 2013 and \$1.7 million for 2014.
