AUDIT SUMMARY

Results in brief

In the areas we audited, Commission operations complied with applicable requirements and provided adequate safeguarding of public resources. The Commission also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Columbia River Gorge Commission from July 1, 2011 through June 30, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Commission's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash Receipting
- Payroll
- Professional Service Contracts
- General Disbursements

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE COMMISSION

The Columbia River Gorge Commission was authorized by the 1986 Columbia River Gorge National Scenic Area Act, and created by an interstate compact between Oregon and Washington in 1987. The Commission was established to develop and enforce policies and programs that protect and enhance the scenic, natural, cultural and recreational resources of the Gorge. In addition, the Commission encourages compatible growth within existing urban areas of the Gorge, and allows economic development outside urban areas, consistent with resource protection. Washington and Oregon fund the Commission equally.

The Commission's headquarters is located in White Salmon, Washington. It is managed by a 13-member Board of Commissioners, who are appointees from the two states and one-ex-officio, nonvoting member appointed by the U.S. Secretary of Agriculture. The Commission operates under a biennium budget of approximately \$1.8 million. The primary roles of the Commission and its employees are planning, consulting and implementation of the federal Columbia River Gorge National Scenic Area Act.
