AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Skagit Regional Health from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Use of restricted funds
- Contracts and agreements
- Charity care
- Foundation agreement follow-up
- Inventory follow-up
- Accounts payable

Financial

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Skagit Regional Health.

INFORMATION ABOUT THE DISTRICT

Skagit County Public Hospital District No. 1, doing business as Skagit Regional Health, currently operates Skagit Valley Hospital, a 137-bed acute care hospital, and Skagit Regional Clinics, a multi-specialty Clinic with 11 locations and 150 providers. In addition, the District operates the Cancer Care Center and Kidney Center in Mount Vernon. In 2014, the District had 31,087 patient days and nearly 387,000 outpatient visits.

An elected, seven-member Board of Commissioners governs the District. The Board appoints the Chief Executive Officer to oversee the District's daily operations, as well as the 2,110 employees. The District's primary source of operating revenue is from patient services. For 2014, the District operated on approximately \$282 million.
