AUDIT SUMMARY

Results in brief

In the areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Housing Authority of the City of Bellingham from October 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit card and fuel card follow-up
- Maintenance Department
- Cash receipting

- Contracts and agreements
- Disbursments

Financial

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Housing Authority of the City of Bellingham.

Federal grant programs

A firm of certified public accountants evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Housing Authority's major federal programs. That firm's report is available from the Housing Authority of the City of Bellingham.

INFORMATION ABOUT THE HOUSING AUTHORITY

The Housing Authority of the City of Bellingham was established in 1945 to provide and manage housing for low-income residents of the city of Bellingham. Whatcom County Housing Authority contracts with the Housing Authority to administer its programs. In addition, the two entities share a Board of Commissioners. The Whatcom County Executive appoints two members and the City of Bellingham Mayor appoints three members. The combined housing authorities have approximately 51 employees.

The Housing Authority is primarily funded through direct federal grants. For fiscal year 2013, the operating revenue for the Housing Authority was \$21,691,258 and operating expense was \$21,788,441. During fiscal year 2014 the Authority changed its year end from September 31 to December 31. Operating revenue for that year was \$29,413,478 and operating expenses of \$25,618,455.
