## AUDIT SUMMARY

### Results in brief

In the areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Port of Grandview from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Disbursements
- Credit cards
- Small works roster
- On call contracts

## INFORMATION ABOUT THE PORT

The Port of Grandview, located in Yakima County, encourages new jobs by recruiting industries and businesses to utilize the Port's facilities, which are centrally located in Eastern Washington's agricultural region and next to a major state highway.

The Port is governed by an elected, three member Board of Commissioners and employs one part-time administrative assistant. The primary income for the Port comes from rental fees, irrigation water sales and occasional real estate sales. Operating revenues for 2012, 2013 and 2014 were \$290,822, \$299,143 and \$630,381, respectively.
