AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Centralia School District No. 401 from September 1, 2013 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General revenues and expenditures
- Open public meeting minutes
- Significant internal control systems:
 - Cash receipting
 - Payroll
 - Credit cards
 - Disbursements

- Self insurance
- Associated Student Body (high school)
- Small and attractive assets

INFORMATION ABOUT THE DISTRICT

Centralia School District No. 401 provides public school services to approximately 3,600 students in kindergarten through 12th grade in Lewis County. It has one high school, one middle school, five elementary schools and one alternative school. The District operates the Centralia-Chehalis Transportation Cooperative and is a member of the Chehalis-Centralia Student Support Program Cooperative, which is operated by the Chehalis School District.

The District's five-member Board of Directors is the primary policy-making body, exercising budgetary and financial control for the District. Board Members are elected to staggered, four-year terms. The Board appointed Superintendent oversees the District's operations and its approximately 510 employees. For fiscal years 2014 and 2015, the District operated on an annual budget of \$39.2 million and \$40.2, respectively.
