## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Pullman Regional Hospital from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Compliance with grant requirements
- Self-insurance requirements
- Surplus property
- Third party cash receipting

### **Financial**

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Pullman Regional Hospital.

## INFORMATION ABOUT THE DISTRICT

Whitman County Public Hospital District No. 1A, doing business as Pullman Regional Hospital, operates a 25-bed critical access hospital in Pullman. The District provides medical, surgical, labor and delivery, nursery care, 24-hour emergency, laboratory, radiology, physical therapy, cardiac rehabilitation and physician services.

An elected, seven-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its 300 employees. In fiscal years 2013 and 2014, the District operated on annual budgets of approximately \$43 million and \$45 million, respectively.
