AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Kent School District No. 415 from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Career and Technical Education (CTE)
- Travel expenses

- Credit card transactions
- Financial condition

INFORMATION ABOUT THE DISTRICT

Kent School District No. 415 serves approximately 72 square-mile area including most of the City of Kent, all of the City of Covington, portions of the Cities of Auburn, Black Diamond, Maple Valley, Renton, SeaTac and a significant portion of unincorporated King County. The District serves approximately 27,500 students in kindergarten through 12th grade and operates four high schools, six middle schools, 28 elementary schools and three academies.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 3,737 employees. For fiscal year 2015, the District's final general fund budget was approximately \$307 million.
