AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated April 20, 2016, related to Career and Technical Education enrollment reporting. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Stanwood-Camano School District No. 401 from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Career and Technical Education enrollment reporting
- Fuel cards
- Travel and credit cards
- Procurement
- Information technology/data security
- Open Public Meetings Act
- Special education

INFORMATION ABOUT THE DISTRICT

Stanwood-Camano School District No. 401 serves approximately 4,400 students in kindergarten through 12th grade. The District includes the northwest portion of Snohomish County, as well as Camano Island of Island County. The District operates five elementary schools, two middle schools, one high school, an alternative middle school, an alternative high school, a variety of on-line courses and a parent-partnered educational program. In addition, the District provides services for preschoolers with developmental delays.

An elected, five-member Board of Directors governs the District. Directors serve staggered, four-year terms. A Board-appointed Superintendent oversees the District's daily operations as well as its staff of approximately 575 employees. For fiscal year 2015, the District had \$53,374,739 in total revenues and \$53,161,283 in total expenditures.
