AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated June 28, 2016, related to small and attractive assets. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Marysville from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billing and receivables
- Payroll – lump sum payments
- Financial condition
- Small and attractive assets – parks and public works
- Police department review

INFORMATION ABOUT THE CITY

The City of Marysville encompasses just over 20.9 square-miles in Snohomish County, and serves 64,140 citizens. The City provides a variety of services including public safety, planning and zoning, street maintenance, water, sewer, storm water, solid waste, parks and recreation, a municipal golf course, a municipal court, jail services and general government services. The City contracts with the Marysville Fire District for fire and emergency medical services.

An elected, seven-member Council and a separately elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its 266 employees. For fiscal year 2015, the City reported general fund expenditures of approximately \$38.7 million.
