## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Maple Valley Fire and Life Safety from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- Petty cash funds
- Fundraising activities
- General disbursements

## INFORMATION ABOUT THE DISTRICT

King County Fire Protection District No. 43, doing business as Maple Valley Fire and Life Safety, provides fire protection services to a 53 square-mile area, which includes the city of Maple Valley and unincorporated areas of King County. In addition to fire protection, the District provides fire prevention, public education and training to the citizens within the District.

The District is governed by a five-member Board of Commissioners. The District maintains six fire stations staffed by approximately 52 career and 20 volunteer firefighters including administrative employees. For fiscal year 2015, the District had an annual budget of approximately \$9.1 million.
