AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Edgewood from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Controls over credit card usage.
- Use of restricted LID funds
- Building permit fee calculations and payment receipts

INFORMATION ABOUT THE CITY

The City of Edgewood, incorporated on February 28, 1996, serves approximately 9,460 citizens in Pierce County. In November of 2014, citizens voted to change the City's form of government from a Council/City Manager organization, to a Mayor/Council form of government. The Council is an elected, seven-member group. One member of the Council is selected by the Council to serve as Mayor.

The City has one part-time and seven full-time employees. For fiscal years 2014 and 2015, the City's general fund budget was approximately \$5.1 million. Many of the primary municipal services such as police, fire and utilities are provided by other government units or through contracts.
