AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Edgewood Transportation Benefit District from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Use of restricted funds

INFORMATION ABOUT THE DISTRICT

The Edgewood Transportation Benefit District was established in 2013 to collect special transportation taxes authorized by RCW 36.73. The District was governed by a seven-member Board, which was the same as the Edgewood City Council.

The District had no employees. Its sole activities were to collect taxes and remit them to the City of Edgewood under an interlocal agreement. The District collected \$58,000, \$157,000 and \$162,000 in taxes for 2014, 2015 and 2016, respectively. The District was assumed by the City of Edgewood January 1, 2017 pursuant to RCW 36.74, and no longer exists after that date.
