AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Vancouver School District No. 37 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body revenues and fundraising
- Self insurance programs
- Cash receipting business offices and food service
- Open public meeting minutes
- Internal controls over accounts payable
- Internal controls over payroll system

- Payroll expenditures
- Procurement (bidding)
- Student transportation reporting
- Procurement card and travel payments
- Internal controls over fuel and supplies for bus operation

INFORMATION ABOUT THE DISTRICT

Vancouver School District No. 37 serves approximately 23,000 Clark County students, kindergarten through 12th grade. The District has four high schools, seven middle schools, 22 elementary schools, two buildings that serve 6th through 12th grade, and five alternative programs.

An elected, five-member Board of Directors governs the District. Board Members are elected to four-year, staggered terms. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 3,000 employees. For fiscal year 2016, the District had revenues of \$292 million.
