## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Meridian School District No. 505 from September 1, 2013 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Enrollment apportionment
- Staff mix apportionment
- Associated Student Body

## INFORMATION ABOUT THE DISTRICT

Meridian School District No. 505 serves approximately 1,680 students in kindergarten through 12th grade in Whatcom County.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations and its 242 employees. For fiscal years 2014, 2015 and 2016, the District operated on general fund revenues of approximately \$17.2 million, \$17.8 million and \$19.9 million, respectively.
