AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Kahlotus from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Finanical condition
- Insurance coverage
- General disbursements
- Donations

- Petty cash funds
- Payroll disbursements
- Cash receipting

The City of Kahlotus, incorporated on May 6, 1906, has as a mayor-council form of government. The City and its two employees provide water and garbage services to approximately 114 customers.

Four Council Members govern the City. The City had revenues of \$187,699 and \$196,085 in fiscal years 2014 and 2015, respectively.
