AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Riverside School District No. 416 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Insurance/risk management
- Associated Student Body
- Cash receipting
- Safeguarding of small and attractive assets such as computers
- Payments/expenditures

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. That report includes a federal finding regarding internal control weakness and noncompliance related to suspension and debarment requirements in the Title I program that was required to be reported. INFORMATION ABOUT THE DISTRICT

Riverside School District No. 416 serves approximately 1,428 students in kindergarten through 12th grade in Spokane County. The District has two elementary schools, one middle school, one high school, one alternative high schools and a home-link program.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent who is responsible for the day-to-day operations as well as its 198 employees. For fiscal year 2016, the District operated on an annual general fund budget of approximately \$18.4 million.
