## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Tukwila School District No. 406 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Controls over key software applications, including electronic approvals, backup and user access
- Financial condition and fiscal sustainability
- Citizen concerns over use of bond funds related to the birth to five center and use of special education funds
- Procurement – public works, change orders, prevailing wage and on-call contracts
- Associated Student Body (ASB) – student body operations, cash receipting, fundraisers and student store activity, and lunch room cash receipting at one middle school and one high school
- Basic and bilingual enrollment reporting to the state
- Rental and leases revenue – activity and cash receipts

## INFORMATION ABOUT THE DISTRICT

The Tukwila School District, located in King County, serves approximately 2,862 students from preschool through the 12th grade. The District operates one high school, one middle school and three elementary schools.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 399 employees. For the 2016-2017 fiscal year, the District operated on an annual general fund budget of approximately \$44 million.
