## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the City of Olympia from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Disbursements – Evaluated design of controls in the administrative services department and tested travel and credit card transactions citywide
- Self-Insurance for unemployment and workers compensation
- Compliance with interlocal agreements
- Procurement – competitive bidding requirements related to piggybacking
- Controls over third party cash receipting
- Tracking and monitoring of theft sensitive assets within the Info Services Records Department
- Financial condition and fiscal sustainability
- Open public meeting minutes

## INFORMATION ABOUT THE CITY

The City of Olympia is located in Thurston County and is the county seat and the Washington State Capital. The City provides its 52,160 citizens a full range of municipal services including public safety (police, fire, court and jail), sanitation, utility (water, sewer and stormwater), streets, parks and recreation, arts, community planning and development, zoning and general administrative services.

The City is governed by a council-manager form of government with seven elected Council Members including the Mayor who is elected to position one of the Council. The Council appoints a Manager to oversee the City's daily operations as well as its 591 full-time equivalent employees. In fiscal year 2017, the City operated on a general fund budget of \$94.4 million.
