#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of East Pierce Fire & Rescue from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll gained understanding of controls over payroll and overtime and perform overtime testing for select employees.
- Credit Card Purchases gained understanding of controls over credit card purchases and performed testing of select transactions.
- Procurement for purchases sole source contracts, purchases from other entity's contracts (piggybacking) and market conditions procurement exemption.

### INFORMATION ABOUT THE DISTRICT

Formerly Pierce County Fire Protection District No, 22, East Pierce Fire and Rescue (EPFR) was created when the City of Bonney Lake Fire Department, Lake Tapps Fire and Pierce County Fire District 24 merged in 2000 to provide 24-hour emergency medical and fire suppression services. Since then, other cities and fire protection districts have merged with the Department including Pierce County Fire District No.'s 1, 8 & 12, South Prairie Fire District 20, and the Cities of Sumner and Milton.

Today, EPFR serves a population of 94,000 citizens living in and around Bonney Lake, Sumner, Lake Tapps, Edgewood, Milton, South Prairie, and the Ridge Communities. The District covers approximately 153 square miles and protects residents from twelve stations – six staffed and three volunteer, a logistics warehouse, and one water rescue facility. All full-time firefighters are cross-trained as either emergency medical technicians (EMTs) or paramedics and are able to respond to both medical emergencies and fires. The Department's 64 career firefighter-EMTs, 42 career firefighter-paramedics, 16 volunteer firefighters and 25 other command staff members and administrative staff are divided into eight divisions. These divisions include the Operations, Emergency Medical Services, Volunteer, Training, Fire Prevention, Safety, Emergency Management, and Budget and Finance divisions.

An independently elected, seven-member board of citizens, called Fire Commissioners, governs the District. The Board currently consists of seven commissioners. Voters approved a measure to maintain a seven-member board in fiscal year 2014. For fiscal year 2017, the District operated on a budget of approximately \$33.2 million for the General Fund.
