## AUDIT SUMMARY

### Results in brief

Based on the procedures performed, nothing came to our attention in the areas we reviewed that caused us to believe the Council was not in substantial compliance with applicable state laws, regulations, and its own policies, or had significant weaknesses in controls over the safeguarding of public resources. Had we performed additional procedures, other matters might have come to our attention that would have been reported.

### About the assessment audit

This report contains the results of our independent audit of the West Region EMS and Trauma Care Council from July 1, 2015 through June 30, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives. Local governments are also required by state law (RCW 43.09.230) to prepare and submit certified annual reports to our Office summarizing such things as revenues received, collections made, amounts receivable or payable, expenditures made, and debt owed.

This assessment audit was conducted under the authority of RCW 43.09.260, which requires the State Auditor's Office to examine the financial affairs of all local governments at least once every three years. Assessment audits are risk-based, limited-scope reviews of small local governments, generally defined as local governments with less than \$300,000 in annual revenues. To help minimize audit costs, our work for this engagement was conducted off-site primarily using financial and other information provided by the Council.

This assessment audit was limited to the following:

- Reviewing meeting minutes for compliance with the Open Public Meetings Act.
- Inquiring as to internal controls over assets, revenues, and disbursements.
- Verifying that annual reports submitted to our Office were complete and filed timely in compliance with state law.
- Reviewing the Council's annual revenues and expenditures for unusual transactions or trends.
- Corroborating financial information reported by the Council by comparing its annual revenues, expenditures, and cash and investment balances to third-party sources.

- Reviewing expenditures for indications of unusual activities, excessive Board of Commissioners compensation, conflicts of interest, or procurement requirements.
- Evaluating the Council's financial information for indications of financial difficulties.

## INFORMATION ABOUT THE COUNCIL

West Region EMS and Trauma Care Council works with the Washington State Department of Health (DOH) and regional healthcare partners to ensure the continuation of the emergency medical services and trauma care system in west Washington. The Council is empowered by legislative authority and Department of Health Administrative Code to plan, develop, and administer the EMS and trauma care system in the counties that make up the region. The Council is governed by an eight-member Executive Board representing the member counties.

The Council's region is comprised of Grays Harbor, Lewis, North Pacific, Pierce and Thurston Counties. The Council operated on annual budgets of approximately \$264,000 and \$253,000 in fiscal years 2016 and 2017, respectively.
