#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Quincy-Columbia Basin Irrigation District from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

• Procurement (bidding)

• Payroll/personnel

Cash receipting

#### RESULTS

#### ABOUT THE DISTRICT

The Quincy-Columbia Basin Irrigation District was incorporated in 1939 when it separated from the U.S Bureau of Reclamation. The District operates and maintains irrigation systems serving approximately 250,000 acres located in the Columbia Basin area of Washington.

An elected, seven-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 110 employees. For fiscal years 2011 and 2012, the District operated on annual expenses of approximately \$19.4 million and \$19.7 million, respectively.
