## **Audit Summary**

### Greater Columbia Behavioral Health Benton County March 7, 2014

#### **ABOUT THE AUDIT**

This report contains the results of our independent accountability audit of the Greater Columbia Behavioral Health from July 1, 2012 through June 30, 2013.

We evaluated internal controls and performed audit procedures on the activities of the Network. We also determined whether the Network complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Contracts
- Credit card disbursements
- Employee reimbursements

- Payments/expenditures
- Travel disbursements

#### **RESULTS**

In the areas we examined, the Network's internal controls were adequate to safeguard public assets. The Network also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### ABOUT THE NETWORK

Greater Columbia Behavioral Health Regional Support Network is a health plan contractor for the state of Washington for mental health services. Created under the Community Mental Health Services Act passed by the Washington State Legislature in 1991, the Network is under contract with the Department of Social and Health Services to coordinate mental health services to individuals covered by Medicaid or with limited financial resources and no health insurance.

The Network is organized as a quazi-governmental agency made up of 10 counties including Asotin, Benton, Columbia, Franklin, Garfield, Kittitas, Klickitat, Walla Walla, Whitman and Yakima. The Network Business Office does not provide direct services, but instead contracts service delivery through a network of private nonprofits and countyrun agencies. A 10-member Board of Directors governs the Network. Each Board Member represents a member county. The Network operates on \$55 million annually with a \$110 million bi-annual budget and has approximately 20 employees.
