#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Coulee Medical Center from January 1, 2012 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

• Charity care write-offs

• Credit card expenses

#### RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### **Description of the District**

#### ABOUT THE DISTRICT

Grant, Lincoln, Douglas and Okanogan counties own and operate Grant County Public Hospital District No. 6, doing business as Coulee Medical Center. The District is a 25bed critical access hospital with an acute care and skilled nursing facility and physicians' clinic. Additional services provided by the District include acute hospital care, long-term skilled nursing care, emergency room services, physicians' clinics and related procedures, such as lab and X-ray.

An elected, five-member Board of Commissioners governs the District; however, one Board position was vacant during the audit period. The Board appoints an Administrator and a Chief Financial Officer to oversee the District's operations as well as its approximately 200 employees. District operating expenses in 2012 were \$22.5 million.

#### AUDIT HISTORY

We typically perform an accountability audit of the District annually. The District received a finding in the 2004 accountability audit for unauthorized patient account write-offs and received a finding in 2009 for directly operating a foundation. Both findings have been resolved.
