ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Mount Baker School District No. 507 from September 1, 2011 through August 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Student transportation reporting
- Teacher education and experience (staff mix) reporting
- Third party cash receipting
- Open Public Meetings Act

- Payroll and benefits
- Prior audit issues:
 - Associated Student Body parking permit revenue
 - Timely deposits

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

Mount Baker School District No. 507 provides educational services to approximately 1,800 students in kindergarten through 12th grade in Whatcom County. The District operates one high school, one middle school, three elementary schools, a preschool and an alternate program.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 300 employees. Revenue is derived from state apportionment, federal grants and local property taxes. For fiscal years 2012 and 2013, the District's operating expenditures were \$21,104,826 and \$20,689,553, respectively.
