ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Evergreen Health from January 1, 2012 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Financial condition
- Payroll
- Conflict of interest
- Bid law compliance
- Foundation
- Credit cards

- Safeguarding of assets pharmaceutical inventory
- Surplus
- General disbursements
- Mileage reimbursements

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

FINANCIAL

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Evergreen Health.

FEDERAL GRANT PROGRAMS

A firm of certified public accountants evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs. That firm's report is available from Evergreen Health. That report includes federal findings regarding significant deficiencies in internal controls over reporting, eligibility, the review of payroll, and the review of required forms. The deficiencies were not considered to be material weaknesses.

Description of the District

ABOUT THE DISTRICT

King County Public Hospital District No. 2 was established in 1972 and serves more than 850,000 people in north King and south Snohomish counties. The District operates as Evergreen Health and is licensed to operate a 290-bed hospital and a network of primary and urgent care centers. The District's specialties include a maternity center, a cancer center, hospice and home health care, 24-hour emergency care, a critical care unit, cardiac care and surgical services.

An elected, five-member Board of Commissioners governs the District. Commissioners serve staggered, six-year terms. The Board appoints management to oversee the District's daily operations as well as its approximately 3,460 employees. For fiscal year 2012, the District had an operating budget of approximately \$446.5 million. The District reported a net operating gain of approximately \$680,000 during fiscal year 2012.

We audit the District on an annual basis. The past five audits have reported two findings. The fiscal year 2007 audit reported one finding related to noncompliance with competitive bid requirements. The fiscal year 2008 audit reported one finding related to internal control over decentralized cash receipting locations. These findings have been resolved. No findings were reported in the 2009, 2010 or 2011 audits.
