ABOUT THE AUDIT

This report contains the results of our independent accountability audit of King County Fire Protection District No. 14 from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

• Dissolution of entity

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

Description of the District

ABOUT THE DISTRICT

King County Fire Protection District No. 14 provides fire protection services to the Factoria and Eastgate areas and along Newport Way in Bellevue through a contract with the city of Bellevue. The District maintains one fire station staffed by city firefighters. The District received approximately \$760,000 for 2011 and \$790,000 for 2012 in taxes, which it paid to the city under this contract. An elected, three-member Board of Commissioners governs the District.

The community, which was served by the District, was annexed by the city on July 31, 2012. As a result, the city began managing the District until it officially dissolved on January 1, 2013. The District is now a part of the city and the Board was released.

Prior to the District's dissolution, we audited the District on a three-year cycle. Except for a finding regarding a noncompliance with state reporting requirements during the 2004 audit, the District has been free of findings. The prior year finding has since been resolved.
